## Acceptable Use Agreement for Pupils

Digital technologies have become integral to the lives of children and young people, both within and outside school. The easy availability of the internet and many other digital technologies, along with powerful tools such as mobile phones and games consoles, mean that new opportunities are opened up for everyone. These technologies can promote creativity, stimulate discussion and stimulate awareness of context to promote effective learning.

Young people should have an entitlement to safe access to the internet and digital technologies at all times. The enclosed Acceptable Use Agreement (below) is intended to ensure that:

- children will be responsible users and stay safe while using the internet and other communications technologies for educational, personal and recreational use whilst at school.
- school systems and users are protected from accidental or deliberate misuse that could put the security of the systems and users at risk
- parents and carers are aware of the importance of online safety and are involved in the education and guidance of children with regard to their online behaviour and the amount of time they spend online.

The school will try to ensure that pupils have good access to digital technology to enhance their learning and will, in return, expect pupils to agree to be responsible users.
